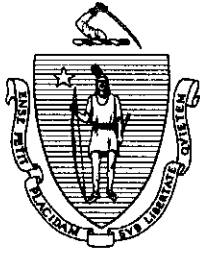

In addition to filling out the attached application completely, you must provide the following:

- If you are a first time applicant or your license has been expired for more than 18 months you must pass a firearm safety course prior to submitting this application. Refer to attached sheet. ***This is not applicable if you are applying for a chemical spray (Restricted Class "D") FID card.***
- You must have a picture ID., i.e. Massachusetts drivers license or state ID card and a bill (gas, electric, etc.) confirming your name and address.
- A fee of one hundred dollars (**\$100.00**) is applicable for class A&B License to carry and a Class C FID cards. A fee of twenty five dollars (**\$25.00**) for a first issue class D (chemical spray) FID card. Check or money order should be made payable to the "*Town of Winthrop*". **No cash** accepted.
- There is no charge for persons seventy (70) years of age and older and no charge for class D FID renewal. This is a State regulated fee.
- You must present the application in person to the firearms officer and stay for processing. (This usually takes 20 to 30 minutes).
- **All correspondence with the Firearms Licensing Office shall be done through email only.** After you have completed the necessary steps as outlined above email the address below to receive a time, at the Licensing Officer's discretion. There is no booking of appointments. After receiving your email, the Firearms Officer will send you an email with a date and time to appear at the Police Station for processing.
