*"Matthew Camilleri reviewed last month's notes summarizing the discussion. It has been determined that no hookahs are to be allowed in the restaurant. This rule was not followed by the Kasbah. Chief Terrence Delahanty noted that there is not a current entertainment license on file. The board goal is to support business within the town, but following rules/compliance is imperative for this to happen. At the current time, the restaurant is not open with the idea of rebranding, renovating, and opening back up. The goal from the owner is to find a way to keep business coming into the town and also remain compliant. Chief Terrence Delahanty suggests to present any business idea to him to have an open dialogue and find a way to keep their business open."*
